- The breeder guarantees to buyer that, at time of transfer the dog's health will be in a good state through a by veterinarian delivered health declaration (mentioned in the vaccination booklet).
- The buyer declares to buy the dog for Domestic dog / Show dog /Breeding dog (*) use only.
- The breeder declares that it cannot give any guarantee for the suitability of Show dog or Breeding dog.
- The breeder declares that the dogs will always be at least 9 weeks old before they will be transferred to buyer.

Additional comment:

The above-mentioned French bulldog have been preventive vaccinated and if older than twelve (12) weeks the dog will be vaccinated with a definitive follow-up vaccination. At transfer the corresponding vaccination book will be handed over to buyer. After transfer, the buyer will have full responsibility to see that the dog gets his/ her required follow-up vaccinations.

1) Disease symptoms:

As soon as the buyer determines a disease symptom, he will consult a veterinarian and adheres to the measures it prescribes. The buyer has in all circumstances the freedom of choice of veterinarian.

The costs of the veterinarian, adhering to the measures as well as other costs associated with treatment, are chargeable on buyer, except for provisions mentioned under number 3.

2) Birth defects and hereditary disorders:

If within ten (10) days, starting on the day after transfer, one of the birth defects mentioned in the list below are determined by a veterinarian and without the breeder reporting its presence in this document, the breeder undertakes, depending on the buyer's choice:

- Or to repay the full purchase price of the dog to buyer, on condition that it returns the dog to the seller/ breeder;
- Or to give the buyer a compensation corresponding to 50% of the purchase price of the dog if the buyer decides to keep the dog;
- Or to be replaced by a dog based on the same breed and gender, in this case the dog that is given for replacement must be the subject of a new guarantee covered by a new purchase contract.

If within 24 months of birth, despite all precautions, hereditary defect still manifest themselves, which are so serious that they threaten or make the quality of life uncomfortable and, in the opinion of the breeder and 1 of the veterinarians listed below, surgery or acceptable euthanasia should take place, the breeder will, after proof of surgery or death, reimburse the costs of medical treatment or euthanasia once, up to a maximum of half of the purchase amount.

It is also stipulated that the treatment of grade1 patella luxation, cherry eye, hernia, stenosis of the nostrils will not be considered.

The seller will only comply with this agreement as soon as he has received a written statement prepared by one of the vets specialized in the French bulldog, mentioned below.

3) Diseases:

In case of death caused by one of the diseases listed in the list below, the seller undertakes to refund the purchase price of the puppy or to replace the dog. Provided that its symptoms were recorded by a veterinarian within the period as defined below:

- -Dog's disease (Carre's Disease): Period of 10 days, starting on the day after the transfer.
- -Parvovirus: Period of 10 days, starting on the day after the transfer.

- -HCC (Hepatitis liver Infection): Period of 10 days, starting on the day after the transfer.
- -Rabies (if older than 12 weeks): Period of 10 days, starting on the day after the transfer.

4) Exceptions:

- The warranty expires when the dog shows serious defects or dies due to the fault or improper act of the owner or third parties.
- Any form of guarantee expires if euthanasia of the dog is started without the written permission of the breeder.
- The guarantee expires when the dog had not received the necessary repeat vaccinations.
- No guarantee can be given on the social aspects and behaviour of the dog.

5) Resale to a third person:

If the buyer resells the dog to a third person, he loses his right to the guarantee stated in nr. 2.

6) Giving up the dog:

If the dog can no longer stay with the owner and/or there are problems with the dog, the breeder will be contacted first, who will look for a home for the dog himself. The owner receives a refund that is determined in consultation with the breeder.

When the dog is older than 2 years, it is ceded free of charge and replaced in the interest of the dog.

In the case of the purchase of a dog, the seller has given the buyer written guidelines regarding the upbringing of the dog and the parties have gone through the list of questions to be asked for the acquisition of a dog.
